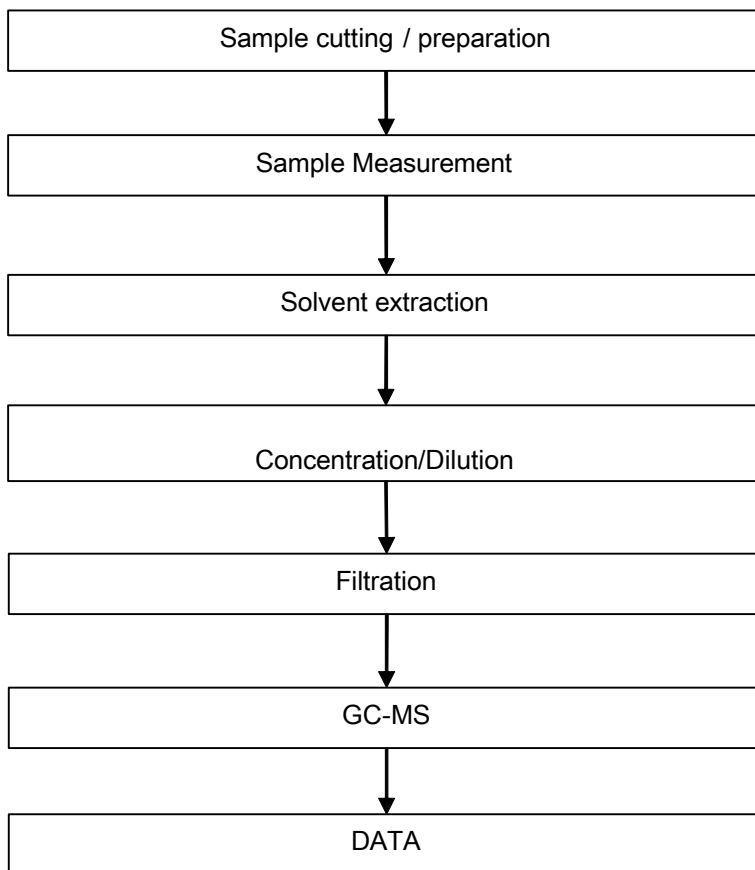

PAHs Testing Flow Chart

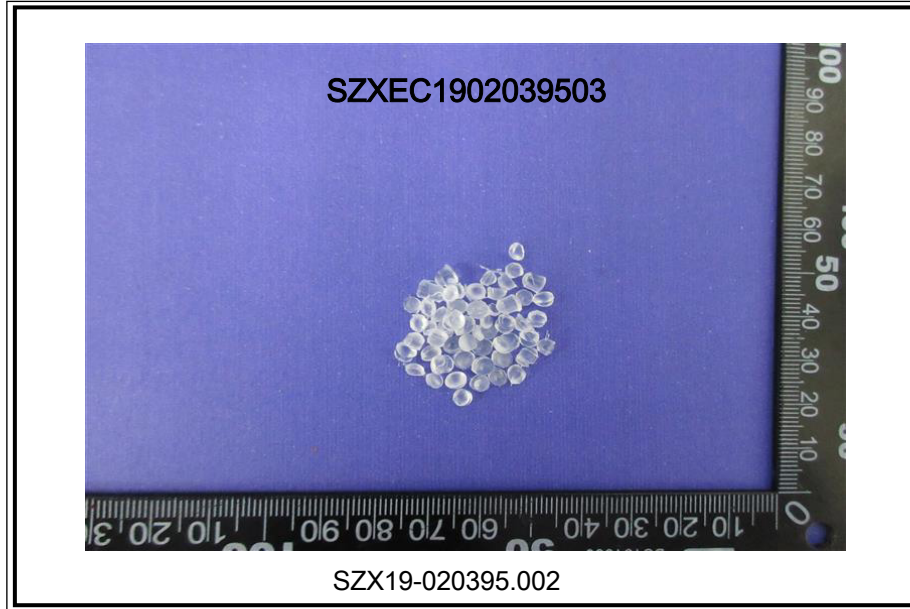
